rules and general information.

1. The craft show committee reserves the right to use their discretion on what type of items can be sold. Other than “branded” vendors, craft items sold should have over 60% handmade. We are not a juried show; however, we reserve the right to remove any item(s) deemed offensive.
2. “Branded” vendors will be allowed into the show on a first come first serve basis. Only one vendor per brand.
3. Tables are to be covered with a clean covering and must be skirted to the floor. We will no longer provide table skirts.
4. Each exhibitor will have a set amount of booth space. This space will be clearly marked. PLEASE do not infringe upon your neighbors. If more space is needed, you will be charged accordingly.
5. Two (2) chairs will be provided at each booth. If you plan to bring your own chairs, please make sure that they have protective coverings on the bottom. We will be set up in a gymnasium and we need to keep the floor nice.
6. Children are welcome to attend the craft show with you, but we would ask that you consider the hours you will be requiring your child to sit and behave.
7. We are requesting your email address for confirmation of your space and/or updated information. If no email address is provided, please make sure we have your phone number.
8. Weapons of any kind, and alcoholic beverages are NOT PERMITTED anywhere in the building or on the grounds. If you smoke, please do so outside and away from the door.
9. **Out of respect for the other vendors you shall not disassemble, pack up or remove any part of your display prior to the official close of the show. Doing so may prohibit you from future shows. All persons and property must vacate the building by 5pm.**
