The Participant (or parent/guardian) accepts personal financial responsibility for any damage to person or property caused by the participant and for any injury sustained during the Activity or during transportation to and from the activity, as well as for any medical treatment rendered to the Participant that is authorized by Cathedral of Life/Trinity Gospel Temple or its agents, employees, volunteers, or any other representatives (collectively referred to hereinafter as the "Sponsor"). Further, the Participant (or parent/guardian) releases and promises to indemnify, defend, and hold harmless the Activity Sponsor for any injury arising directly or indirectly out of the described Activity or transportation to and from the Activity, whether such injury arises out of the negligence of the Sponsor, or the Participant, or otherwise. If a dispute over this agreement or any claim for damages arises, the Participant (or parent/guardian) and the Sponsor cannot agree upon such a process, the dispute will be submitted to a three-member arbitration panel of the American Arbitration Association for final resolution. I further expressly agree that in the event of disciplinary action or the health of the participant, may make it necessary at the discretion of the sponsors, the participant may be forthwith returned home at the parent's/guardian's expense. It is further warranted that if this Activity Participation Agreement is signed by one parent or guardian, it is with the authority of the other.
